Meeting Notes

June 2, 2017 – Brooks Worship Center

Note: Only 2 of 14 attendees plan to remain in the neighborhood

The purpose of the Livability Plan Subcommittee is:

- To make recommendations to the Texas Department of Transportation (TxDOT) on when to complete the Livability Plan and how to make the information most useful to the Northside Neighborhoods.
- To keep abreast of land use changes in the neighborhood due to property acquisition, City of Corpus Christi (City) actions, and development initiatives.
- To determine how the neighborhood is going to shepherd the Livability Plan as their own program.
- To provide input to Flatiron Dragados, LLC (FDLLC) on design issues in the neighborhood related to the bridge project and to provide input to the City and TxDOT on park mitigation plans.

The Subcommittee participants introduced themselves and spoke about what they would like to accomplish to make the neighborhood more livable for those who will stay in the neighborhood. Their suggestions included:

- Have more code compliance to accomplish clean-up and weed control.
- Provide some financial assistance to people who remain in the neighborhood, to help them clean it up.
- Develop a way to deal with homeless people and provide them a place to sleep in a warm bed at night. Develop an overall plan for addressing the needs of the homeless, including social programs.
- Maintain the demolished sites so they do not become nuisance areas.
- Assess the economic impact of new development coming into the area.
- Address noise pollution.
- Address air pollution.
- Make street improvements.
- Build a sense of community by providing some eating places and shopping opportunities, since there is no shopping center.
- Provide better street lighting.

Chris Amy, TxDOT, described the history of the Livability Plan project: TxDOT wanted to provide meaningful mitigation for the neighborhood. The Harbor Bridge Community Advisory Committee brought up the concept of developing a sustainability plan for the neighborhood, something that would help preserve the neighborhood. This led to the recognition that a neighborhood improvement plan ("Livability Plan") was needed for the Washington Coles and Hillcrest neighborhoods. Two workshops were held with the neighborhoods a couple of years ago; community members identified



needs and potential strategies to address those needs. The consultant began to identify resources that could be applied. A Title VI complaint was filed with Federal Highways Administration that led to the Resolution Plan, setting up the Voluntary Acquisition and Relocation Program to enable residents to leave the neighborhood if they wished. TxDOT wants to work both on the Livability Plan to help what remains of the neighborhood to keep going and the Acquisition Program that enables people to leave.

The Livability Plan will serve as a guide for the neighborhood to implement. TxDOT is asking the subcommittee to provide guidance on how best the neighborhood can develop and have meaningful improvements.

Chris explained that it is important to identify what is already known about land use in the area and add to this information as changes occur. What is known includes:

- Properties are being sold and vacated through the Voluntary Acquisition and Relocation Program.
- The Sea District is planning to bring in a new Hilton Hotel.
- The parks will remain, although their final design has not yet been determined.
- Washington Coles Park will be an anchor in the neighborhood.
- The Oveal Williams Senior Center and the clinic will remain.
- The Solomon Coles and Elliott Grant Schools will remain.
- Christus Spohn Clinic will remain.
- TC Ayers Park will provide connection points in the area.
- The H.J. Williams Park and the cemetery will remain.

Pastor Adam, the Chair of the Subcommittee, added the following comments:

- There will be route changes in the road system in the area.
- It is unknown what the Port is planning for the area and for the properties it is buying. It will be helpful for the Port to participate in Subcommittee meetings, so the community can hear what the Port is thinking about doing.
- The community will have input on the park areas. As this involves important mitigation decisions, the community will need to take its time, get educated about the options, and focus on those aspects that are open for community input.
- The neighborhood needs to develop a vision and work toward that vision.

Karen Costanzo, City of Corpus Christi, reported that:

- The City has a new Planning Department.
- The City is working on bringing back the downtown development plan, including North Beach (by end of summer).
- The Comprehensive Plan for Corpus Christi has been adopted, and she is using it as her guidance in moving forward. Hillcrest is described in the Plan.
- She is getting caught up on earlier plans that were produced for and/or adopted by the City.



Jay Rohleder of FDLLC used a map to explain what is going on with the bridge project at this time and its potential effect on the neighborhood's future.

- The bridge will be a cable stay bridge that will be an important visual focal point for the community.
- FDLLC has already gathered input on and is developing the lighting scheme for the bridge.
- The view of the bridge can have value and serve as an attraction that will draw various activities (such as food trucks, restaurants). The community should think about what they want to attract to the neighborhood.
- The destination at one end of the bridge can help the destination at the other end of the bridge, and the overlook in the middle of the bridge will relate to both destinations.
- The Port is committed to developing the D.N. Leathers property as a Gateway Plaza.
- The bridge presents a potential opportunity to help the City set direction. The bridge will be an elegant look.

Chris Amy reminded the group of the need for continuous updates on information regarding actual sales of the property in the neighborhood. Out of approximately 500 properties in the neighborhood, owners from about 240 of these have expressed interest in participating in the Voluntary Acquisition and Relocation Program. Information on the location of these properties will be provided after each sale has closed and the property has been vacated (but not while the property is in the process of being sold). He noted the importance of providing accurate information and avoiding even the appearance of trying to influence people's decision to stay or leave. TxDOT has 15 acres dedicated for parks including T.C. Ayers and H.J. Williams Park. Chris Amy and Pastor Adam expressed the need to engage more community members in the Subcommittee's work, especially those individuals who plan to stay in the neighborhood.

Short Term Strategies Discussion Points

The goal of the Northside Neighborhoods Livability Plan is to identify strategies that can address the desire of current residents who expect to remain in their homes for the foreseeable future, to have a viable community that is safe, includes fundamental public and private services and access to those services, and restores a positive sense of place. At the same time, this plan recognizes: (1) that there are residents who wish to leave the neighborhood and to have greater financial ability to do so than at present; (2) that the City of Corpus Christi is developing a long-term plan for this area. The interests of those who wish to stay, those who wish to leave, and the City of Corpus Christi, although seemingly disparate, are not mutually exclusive when viewed over a likely timeframe. Improvement to the quality of life in the Northside Neighborhoods may attract individual, governmental, and corporate buyers; this can lead to greater opportunity for potential sellers and thus benefit those exiting the neighborhoods. Meeting the immediate livability needs of current residents involves short-term strategies.

Implementation of the City's vision for the area will evolve over a longer time horizon. Clarity of the City's intentions for this area can help ensure that near-term actions taken to enhance the livability of the area are compatible with the City's long-term plan and lead to mid-term actions and investments that can transition the area in keeping with the City's vision.

Short-term strategies that have been identified as a result of information-gathering about community needs, during the Northside Neighborhoods Livability Plan meetings include:

- Clean-up of the neighborhoods by:
 - Enforcement of existing City codes
 - Engagement of the police in removing transients who are not renters or owners in the area and responding to residents' calls regarding disturbances
 - Engagement of community volunteers in trash pickup and weed clearance
 - Removal of structures that are unsafe or "attractive nuisances"
- Provision of public and private services that support a community
 - Encouragement of private investment in local businesses such as grocery stores, pharmacies, coffee shops, etc.
 - Provision of mobile services, such as weekly food trucks that sell fresh food; book mobiles; mobile medical services, etc.
 - Consolidated and disseminated information about available services
 - Service fairs or temporary mobile offices at convenient locations where representatives of private, non-profit, and public services can provide information on what is available and how to access those services and programs
 - Use of volunteers and service groups (Americorps? Is there a local college/university social work program that has internships?) to distribute information about services and programs to residents and canvass residents regarding individual needs
- Access to safety information
 - Provision of accurate information about the status of air, water, and soil quality and information about practices residents should employ for healthy living
 - Education about emergency plans related to the refineries, evacuation plans, and communication channels and protective measures in the event of an incident



- Infrastructure improvements to enhance safety and access
 - Sidewalk improvements to provide continuity and smooth movement
 - Lighting improvements at specific areas to eliminate “dark corners” conducive to dangerous activity and to enhance pedestrian and vehicle mobility
- Transportation mode enhancements
 - Increased knowledge of and access to on-demand services, including volunteer pick-up services
 - Modifications to bus routes to make them congruent with current travel needs
- Aesthetic improvements to create a sense of place and neighborhood value
 - Banners that evoke the area’s unique cultural history
 - Updated signage
 - Programs to encourage property upkeep and enhancement
- Programs to make housing more sustainable
 - Identification of programs that provide loans and grants for home improvement and how to access these
 - Community-developed expectations for home maintenance
 - Volunteer programs to provide repair and maintenance assistance
- Social programs to strengthen community connections and a sense of belonging
 - Engagement of the churches in planning and implementing community events
 - Development of a community calendar of events
 - Youth activity programs that link schools, recreation centers, etc.
- Access to information about plans that may affect the area
 - A conveniently located repository or periodic mobile “library” of City, refinery, TxDOT, and developer plans, with contact information available
 - A communications committee that serves as a conduit of information between the neighborhoods and the City, refinery, TxDOT, and developers
